WAIVER AND RELEASE OF LIABILITY

In consideration for being allowed to participate in any activity whatsoever of the Utah Miata Club, the above named, whether a single participant, or two participants jointly, hereafter known as Releasor, acknowledges there are risks associated with participation in club activities such as physical and psychological injury, pain and suffering, illness, disfigurement, temporary or permanent disability, death, or economic harm. These injuries or outcomes may arise from the actions, inactions, negligence, location conditions, facilities, or venues where activities take place, including on any and all public or private roadways, whether by the Releasor or by co-participants. Releasor is a willing and voluntary participant in all activities and accepts all risks without hesitation or reservation.

The Releasor, its heirs, executors, assigns, legal and personal representatives does knowingly and willingly covenant and promise to:

1. Accept full and sole responsibility for Releasor's actions.
2. Waive Releasor's right to sue Miata Owners of Utah Incorporated, DBA the Utah Miata Club, its Officers and representatives.
3. Fully indemnify and hold harmless Miata Owners of Utah Incorporated, DBA the Utah Miata Club, its Officers and representatives for and in any and all claims, loss, damage, injury or liability which may be asserted against them by Releasor as a result of participation in club activities, including but not limited to claims for negligence resulting in physical injury, illness, death or economic harm.

The foregoing covenants of exculpation and indemnification are intended to be and are complete, general and without restriction, and include but are not limited to active or passive negligence, or willful, reckless, or wanton activity. Releasor hereby acknowledges advance understanding of this Waiver and Release of Liability, and, before signing, has consulted with an attorney to the extent desired.

While participating in any Utah Miata Club activity the Releasor further agrees:

1. That a licensed driver will operate the Releasor's vehicle at all times.
2. The driver will comply with all state and local traffic laws and regulations.
3. To carry and maintain in full force automobile liability insurance that meets or exceeds all Utah statutory requirements.
